LIVING IN THE RUHR AREA

All three universities are embedded in an unequalled metropolitan area (Rhein-Ruhr area) in Germany. Over decades the region has transformed itself from a coal and steel industrial site to a service and culture-oriented region. The high concentration of large cities in the Rhein-Ruhr region (e.g. Bochum, Duisburg, Essen, Dortmund etc.) offers international students plenty of opportunities for day-trips and cultural activities in one of the five largest conurbations in Europe. Exciting excursions to the nearby former capital Bonn, the regional capital Düsseldorf or Cologne are waiting. Each university provides students with a Semester-Ticket (i.e. free access to all public means of transport within North Rhine-Westphalia) in order to explore Germany's most populous federal state North Rhine-Westphalia (17.8 million inhabitants). Thus, students can easily commute between both universities.

STUDYING IN BOCHUM

The Faculty of Social Science pursues a modern interdisciplinary approach to Social Science. One characteristic of our Bachelor's degree is the combination of the five disciplines Political Science, Sociology, Social Psychology and Social Anthropology, Social Policy and Social Economy, as well as Social Science Methodology and Statistics. STUDYING IN DUISBURG

The Faculty of Social Sciences in Duisburg-Essen offers a wide range of courses in the field of political science and sociology. One of the five key research focuses of the university is the Transformation of Contemporary Societies.

The New World of Work and Social Integration constitutes the research focus of the Institute of Sociology at the University Duisburg-Essen. The program in Sociology has a tradition of being praxis-oriented and internationally comparative. Thus, the program is not based on any specific sociological school (instead it draws from various theories), is informed by a specific level of analysis, which views organizations (e.g. associations, parties, workplaces etc.), including their structures and processes, as decisive for understanding stability and change in contemporary societies. Moreover, the program is oriented toward empirical research, with a practical and problem-oriented approach to using and developing the methodological tools of the social sciences. The Institute of Political Science is one of the largest in Germany, working in close cooperation with the INEF (Institute for Development and Peace), the Institute of East Asian Studies, the Rhine-Ruhr Institute for Social Research and Policy Consulting and the NRW School of Governance. The Institutes' research is oriented towards the focus "Governance and Legitimacy in a Globalized World", and structured into three main research areas: Global Governance, Governance and Government in World Regions, and Democratic Governance. In particular students with a high interest in International Relations, Governance, Development Policy, and East Asian Studies can advance their academic and professional competences within these fields.

At present the Institute offers a Bachelor degree program in Political sciences, and Master degree programs in International relations and Development Policy, in Public Management, Public Administration and Public Policies, an English-Language Master degree program in Development and Governance, as well as a Master degree program in Theory and Comparative Studies of Political Systems in Transition.

Course description:

Starting from current developments in the field of EU labour markets and migration, participants will engage with theories of labour market segmentation and theoretical conceptualizations of mi-grant precarity. The seminar will investigate sectors in European economies in which migrants are commonly overrepresented: construction, agriculture, meat industry and care work. Which role does migrant labour play in these sectors? Which types of employment are common? Looking at case studies on employment and working conditions in the respective sectors in different EU member states, students will get an overview of how migrant labour is deployed in these contexts. Attention will also be paid to the underlying reasons for migrant workers' widely reported lack of protection from labour rights violations.

Course description:

The seminar poses the fundamental question of why states establish regional organizations and how successful the regional organizations are in enabling regional integration. It explores the regional cooperation processes of Europe, the Americas and Asia in various fields of International Relations, such as, security, trade, climate and migration. A particular focus therefore is given to the EU (Eu-rope), ASEAN (South-East Asia), NAFTA (North America) and MERCOSUR (South America). The objective of the seminar is to introduce the theories of cooperation and integration, and to enable students to apply these on empirical case studies. Therefore, the students will be familiarized with regional integration theories, mainly neofunctionalism and liberal intergovernmentalism, as well as alternative theoretical approaches of new regionalism and comparative regionalism. Through this the seminar uncovers why some regional organizations are more successful in cooperation. Moreover, it unveils why certain regions are more integrated than others, and whether models of regional cooperation and integration spread across the different regions through diffusion of institutional models and policies.

Course description:

Despite a period of rapprochement and a promising thaw in relations after the proclaimed end of the Cold War, tensions between Russia and the USA have intensified dramatically over the last decade. Divergences and disagreements between the countries in the Eastern Europe and the Middle East, e.g. in the framework of the conflicts in Ukraine and Syria, as well as a lack of cooperation in a range policy fields such as security, energy and trade led to deterioration of relations and introduction of mutual restrictive measures. Why have U.S.-Russia relations become rather tense over much of the last decade? In the quest for the answer to this question, the participants of the seminar will be able (1) to consider the current state of US-Russia relations, (2) to explore the theories of International Relations (IR) that focus on power-based (neorealism) and domestic politics (liberalism, societal approach) explanations and (3) to apply the theoretical knowledge to specific empirical case-studies for the analysis of the driving forces behind the positions of the actors.

Course description:

Analysing social phenomena is what we do as social scientists. Phenomena can be analysed in different ways, though. One of them is applying a theory to empirical research data. Using theories as methodologies for the analysis of research data might show some surprising insights. Yet, some-times theories appear to be too abstract to be applicable to research data. Theories that de-construct phenomena might discourage us to make normative decisions and readings of a convoluted ideal types might leave us with the impression that theories have little to do with reality. At this point, many students lose interest in theories. This seminar aims to (re-)awake the interest in and passion for engaging into theories. Based on texts in English and German, we will discuss four theories as embedded in academic dis-courses and societal necessities. We will examine how the theories ad-dress particular social issues, and how to apply the theories to the analysis of research data. To make the reading of the texts as comfortable as possible, guiding questions to each of the texts will be provided. Students will learn: - How to approach theoretical texts effectively - How to visualize abstract ideas - How to apply theories to the analysis of empirical research data.

Course description:

Digitalisation happens not only in the streets, on your phone and in smart houses. It also happens in science. Here, new digital tools are increasingly applied for data collection, data analysis and data visualisation. What is sometimes called „virtual methods“ typically digitalise existing methods and port them onto the Internet, online surveys for instance. Digital methods, on the other hand, seek to learn from the methods built into online devices in general – such as search algorithms and user profiling – and repurpose them for social and cultural research. This means that traditional social and cultural research methods are rethought through engagement with digital tools and digital data, while however sticking to core principles and legacies of the more traditional methods. Another core aspect of digital methods is its visual outcome, which differs considerably from traditional outcomes of qualitative research. Rather than simply applying this different outcome to yet another way of presenting results, qualitative researchers have acknowledged that data visualisations are helpful communication tools. When gathered around a data visualisation, researchers, informants and practitioners are typically inspired to discover new aspects of their research object, develop new ideas and think about it collectively in novel ways. This both provide qualitative researchers with new material for their studies, and it helps the involved practitioners to develop their concerns in question. One of the methods for doing this is called ‚data sprints‘. In the seminar, we will carry through one week-long data sprint on the RUB’s digital infrastructure. Even though you will learn about this digital infrastructure, this is not the aim of the seminar. The aim is to learn the data sprint method, which is particularly helpful in interdisciplinary work and for research that involves data from heterogeneous fields. A digital infrastructure is thus a good training object, since it connects so many different people and different functions, it depends on a widely distributed work, competencies, energy and resources, it shapes ways in which people can communicate, work together and interact, and it is notoriously difficult to govern, due to its complex and distributed form. Digital infrastructures share this characteristics with many other contemporary social phenomena.

Course description:

The Philosophy of Memory can be traced back as early as Plato who postulated memory traces by likening memory to the imprints of sense impressions on a wax tablet. The current philosophical debate on memory is dominated by two camps. On one side, we face the Causal Theory that holds on to the idea that remembering requires a memory trace that causally links the event of remembering to the event of perception and carries over representational content from the content of perception to the content of remembering (Bernecker, 2010; Martin & Deutscher, 1966). On the other side, a new camp of Simulationists is currently forming up, spearheaded by Michaelian (2016) and Addis (2018). They argue that remembering is nothing, but a specific form of imagination, and differs from hypothetical, counterfactual, future and fictitious imagination only in that it has been reliably produced and is directed towards an episode of one's personal past. The question thus arises whether episodic memory is at all distinct in kind from imagination. As a third option, Werning (2020) has developed an account of minimal traces devoid of representational content. He exploits an analogy to a predictive processing framework of perception. The resulting notion of episodic memory can be validated as a natural kind distinct from mere imaginary processes (Cheng & Werning, 2016). The seminar will provide an overview of the current research literature on memory and imagination, in philosophy, psychology and neuroscience. Students will have the opportunity to link up with our DFG research group „Constructing Scenarios of the Past". Aside from active participation, participants will be expected to give a presentation in English. Assistance regarding the English language will be provided.

Climate change, forced international migration, digitalization and authoritarian populism are distinct (although intricately linked) societal challenges. Public debates on these issues often center on the essentially ethical questions that lie at their root, and it is the answers given to such questions that will then drive political action. However, the academic ethical discussion on such issues can only influence public debates if it tackles the given challenges head-on, if its proposals are solution-oriented and if it is ultimately applicable. But how is an ethicist to proceed methodologically when she is willing to achieve such adaptable results? What are the methodological guidelines for moral reasoning in an invariably imperfect world that one cannot simply assume away when assessing political challenges which, after all, arise only due to such underlying imperfections and injustices? The seminar begins by reasoning on (the criteria of) a methodological framework for applied ethics. By working with that framework when approaching the four political problems, we will test, evaluate and, if needed, eventually refine that methodology. While the methodological concern constitutes the seminar's guiding thread, the focus of each session will lie on the critical examination of philosophical texts, from Henry Shue's take on climate ethics and Joseph Carens' call for open borders to Shoshanna Zuboff's contentions on surveillance capitalism and Martha Nussbaum's plea for hope, love and vision in the face of political crisis.

Course description:

The United States (US) and the European Union (EU) have continuously presented themselves as partners and rivals. Due to the two actors' increasingly diverging perspectives and positions on inter-national issues, institutions and values, and indeed the order of the transatlantic relationship itself, their contemporary transatlantic relationship seems to be undergoing a fundamental transition. Seminar participants will firstly explore the origins of transatlantic cooperation, the creation of common European economic and political structures, notably the EU, and the development of transatlantic security alliances, particularly the North Atlantic Treaty Organisation (NATO). Subsequently, areas of cooperation and tension are examined, including conflicting positions in addressing the financial crisis, international trade and regulatory affairs, climate policy and security problems such as terrorism. Equally of relevance are transatlantic relations with new economies (BRIC) and in the context of multilateral regimes (WTO, IMF). Students are familiarised with main traditions of various International Relations theories (neorealism, institutionalism, liberalism, the societal approach). Their basic assumptions, key drivers, similarities and differences as well as their contributions to the understanding of recent developments in transatlantic relations are highlighted. Students subsequently apply this theoretical knowledge to empirical evidence through case study presentations in order to identify different ways in which transatlantic relations in transition can be examined.

This course will focus on the role of security issues in the international political economy of EU-China relations. Over the past decade, the EU and China have expanded their relations from a dominant focus on economic and trade issues to the sphere of politics. As their shared interests and aims have grown over this time, issues of joint security concerns have become more prominent in their relationship, albeit more in the area of non-traditional security issues than traditional (military) ones and at the bilateral rather than at the global (e.g., United Nations) level. Course description:

Reproductive rights began to develop as a subset of human rights at the United Nation's 1968 Inter-national Conference on Human Rights. It took until 1994 as they were first defined at the Interna-tional Conference on Population and Development (ICPD) in Cairo and included in the Beijing Plat-form in 1995. In Western cultures and politics, reproductive rights comprise the physical and mental wellbeing in relation to all areas of human sexuality and reproduction. This includes the freedom of choice with regard to family planning, e.g. if, when and with whom a family should be formed, how big this family should become, and how a family should be lived and done. The concept of reproduc-tive rights is highly contested since its introduction. This is not only the case among feminists with different social, cultural and geopolitical backgrounds. Also, neo-conservative political and Christian as well as Islamic forces are organising resistance against it on various local and global levels. This tense situation is framed by a demographic situation that on one hand is shaped by low fertility rates in many parts of the Western world since the 1970's and on the other hand consists of an ongoing population growth, especially in many parts of Africa and Asia. Political attempts to raise the fertility rates in the Western world and to limit them in those parts of the world where fertility rates are considered as being too high, are restricted by political, legal and ethical boundaries. In this course we will discuss these developments first by reading and discussing texts about reproductive rights and the politics of reproduction from international women's and gender studies. Secondly, all participants will participate in the international workshop „Contested Reproductive Rights in Turbulent Times: Interrogating the Politics, Ethics, and Practices of Reproduction from Feminist and Intersectional Perspectives“, which will take place on May 14–15, 2020 at RUB.

Course description:

At first glance, we do not hesitate to describe the environment or biology (nature) and human rationality and technology (culture), as separate spheres. This distinction (or „dualism“) is a constitutive part of modern Western thinking and has deep roots in the intellectual traditions of the social sciences and humanities. However, some questions from the contemporary world put us face to face with the intertwining between nature and culture that have led the social sciences to look for new concepts. For example, to what extent do we obey our animal instincts in our social behavior? How do shamans in some cultures have the „ability“to transform into animals? How can we think of hybrid entities that are profoundly both nature and culture, like cloned animals, or animal organs transplants? What does it mean for the cultural imagery of the human that our own body is a biome full of bacteria and other invisible microorganisms? This seminar invites us to explore „naturecultures“as a synthesis that recognizes that ecological relationships are, at the same time biophysical and socially constituted. We will take as a starting point the debate on climate change and the „Anthropocene,“ as an exemplary manifestation of how culture and nature are intertwined. Then, we will look at nature-culture in anthropology to see the different ways in which relations between humans and their environments have been conceptualized. We will review conceptual developments and methodologies such as actor-network theory, multispecies ethnography, multinaturalism, and ontological politics. Through the course, we will explore case studies that make us push the limits of the dichotomy and reflect on how, or to what extent the separation between nature and culture continues to be analytically useful. More than giving answers, the seminar invites to problematize the dualisms and their implications in the society, to think about new concepts and tools, and to challenge our traditional ways of thinking about nature and culture.

Course description:

What is the effect of education on income? Has a job creation scheme created jobs? Does a low in-come leads to voting abstention? These questions are causal questions: does a change in X cause a change in Y? To identify causality, experiments with randomized control and treatment groups are regarded as the gold standard. Oftentimes in social science, only observational data which pose obstacles to causal analysis is available. As one learns in statistics, correlation in this case does not imply causation. But what does imply causation? The seminar will cover methods of modern causal analysis that are trying to overcome the problems of observational data and give an answer to that question. Specifically, the following topics are discussed: 1. the concept of causality based on counterfactuals and directed acyclic graphs (DAGs) 2. two methods for cross-sectional data: regression adjustment and propensity score matching 3. two methods for panel data: fixed effects and difference in differences. The individual topics are presented in an accessible way not relying on mathematical knowledge. Presented methods are applied using real-world examples and applications are carried out in R. Participants will be able to a) think causally and create DAGs, b) critically discuss methods of causal analysis c) and apply causal analysis to answer own research questions.

Course description:

The summer school will provide intercultural and interdisciplinary learning spaces for the analysis of, discussion of, and reflection on experiences as well as challenges related to so-called intercultural encounters. The language of instruction will be English. In the globalized world, intercultural communication and the underlying social competencies are highly relevant in a wide range of internationalized professional fields, organizational settings, and contexts of everyday life. In any kind of intercultural encounters (e.g., foreign assignments, intercultural teamwork, bi-cultural relationships, ethnic conflicts and mediation, many fields of education and academic studies), people and/or ideas from different cultural contexts meet and thereby initiate negotiations with the other, the unfamiliar, the unknown. When engaging with difference, stereotypes, prejudices, reservations, and lack of knowledge can result in culture shock, aversion, or even in disgust and discrimination. So-called intercultural competencies enable us to deal with such critical situations in a skilled manner. Elementary intercultural competence is acquired through training, culture sensitive reflection, coaching, and mediation. It helps to curtail problems and overcome obstacles and thus supports various kinds of successful intercultural exchange. This learning goal will be supported by a cultural psychological, i.e., culture sensitive and culture informed psychological perspective, which enables a reflexive, analytical, and critical approach to the contents, means, and reach of established theories on intercultural communication and competence. Thus, the summer school will open a learning space in which various experts from inter- and transdisciplinary fields will assist in developing a deeper understanding of the connection between culture, thinking, feeling, and acting.

Proofs of academic achievement: Proof of attendance (Studiennachweis): Completion of the preparatory task set in the e-learning Moodle course, continuous participation in the summer school, submission of an essay (approx. 5 pages) that discusses aspects of intercultural communication and competence with respect to their relevance for one's own field of studies and personal interests. Course description:

Relevance of International Accounting

The globalization of financial markets in the last decades affected the information demand on the capital markets significantly. Even though companies disclosed mandatory financial statements according to their local GAAP, as for Germany the Handelsgesetzbuch (HGB), the cross-listing of shares on international stock exchanges as New York, London or Tokyo, forced them to publish more investor-oriented financial information. At the end of the nineties, German companies thus started voluntarily disclosing financial statements according to the International Accounting Standards (IAS)/International Financial Reporting Standards (IFRS). In order to harmonize diverse accounting practices within Europe, the EU-Commission decided the mandatory introduction and enforcement of the IAS/IFRS for consolidated financial statements of public companies since 2005.

The IAS/IFRS focusses on investor-oriented financial information and the true and fair view principle, contrary to the more conservative principles of the German GAAP (HGB) including creditor protection and capital maintenance. Further, the IAS/IFRS are set up according to case law (not code law like the German GAAP) and developed by a private standard setting board, the IASB (International Accounting Standard Board).

Content of the Lecture: The lecture Introduction to International Accounting gives an overview of the fundamental principles and standards within the IFRS framework. We will deal with recognition, measurement and disclosure issues of several IFRS standards, including the revaluation model (IAS 16), the impairment test (IAS 36) as well as the value concept of fair value (IFRS 13). Moreover, we will address additional disclosure elements, like the notes and the management commentary.

In this seminar, students will assume the perspective of a product development team, developing and designing a product prototype. Course description:

Content of the module

In this seminar, students will engage with Brexit from a whole new perspective – their own. Students will represent selected EU countries (such as the UK, Germany, France, Ireland, the Netherlands, Poland, Spain) and lead their own Brexit negotiations. As part of this seminar, students will investigate a country's trade policy and the ways in which that country is tied to the British economy (i.e. economic/trade dependencies and surpluses) and defend that country's perspective in Brexit debates.

The seminar will include several introductory lectures about the EU policy-making process with a special focus on international trade, including:

- Review of international trade theory: customs union, single market, etc.;
- Overview of various trade agreements between EU and other countries;
- Overview of the complex trade interdependencies between EU countries and UK; and
- Overview of the EU institutions and legal processes involved in the Brexit process (European Commission, MEPs, etc.).

As part of this seminar, students will be required to produce and present a policy document summarising their country's policy position. Students representing the EU member states will debate their position with 'the EU' and decide on a common negotiation position to give the European Commission to negotiate with the UK. The UK and European Commission student representatives will submit final policy documents and have a plenary discussion over whether a compromise text can be found.

An international migration is often and in manifold ways a family affair. The family as a fundamental arena of decision making is involved in (re)migration decisions; family-related policies structure migration processes; family life and family biographies are heavily affected by international migration and the family itself influences processes of incorporation and settlement of its individual members. This course sheds light on some aspects of these multiple links between migration and the family. We will discuss how family networks and family-related migration policies affect and help understand migration patterns in various parts of the world. Course description:

Debates on global warming and environmental destruction dominate the political agenda in global forums and national development policies. In this course, we will focus on the concepts of nation and nature that permeate these debates. Departing from the concept of Anthropocene, we will analyze specially the case of Amazon Rainforest and the conflicting positions concerning its preservation or use represented by global, national and Amerindian interests. In 2019, fires destroyed large sections of the forest in Brazil and Bolivia, which yielded an international outcry directed at the Brazilian President, Jair Bolsonaro. In defense of his anti-environmentalist policies, he opposes national development and preservation, seen as a disguise for neocolonialist land-grabbing plans. From this perspective, nation and nature are seen as mutually excluding options. On the other hand, Amerindians conceive nature as multiple, while human culture is seen as just one variation of nature, what Viveiros de Castro (1998) calls "multinaturalism". From this perspective, non-human actors (animals, spirits, rivers, the forest itself, etc.) have their own interest ("cosmopolitics") and may play a central role in the conception of the world, establishing multiple perspectives. During the course, we will discuss also the work of two Amerindian thinkers, Davi Kopenawa (2013) and Ailton Krenak (2015).

Course description:

In Europe, the "summer of migration 2015" has spurred various processes of rebordering – the refinement of existing and the deployment of new methods of border control. Some of these measures raise important questions for social scientific inquiry: Can the erection of walls and other physical barriers really bring migration to a halt? What does the outsourcing of border controls beyond geopolitical demarcation lines – for instance through dubious agreements with transit countries like Turkey or Libya – imply for our understanding of borders? In how far does the establishment of transnational spaces by migrants, fuelled by new modes of communication and transport, call for a reconceptualization of migration beyond its understanding as movement from one national container to another one? And why are migration levels increasing despite the fact that most governments have adopted a harsh anti-migration rhetoric in the past two decades?

By engaging with these and other migration-related questions and debates students will be introduced to the field of *International Political Sociology* (IPS) and cutting-edge debates of border and migration studies. In brief, IPS scholarship seeks to transcend the deeply entrenched traditional boundaries between sociology and political science, on the one hand, and IR theory, on the other hand. Traditionally, all these disciplines (used to) define their respective fields of study along the inside/outside distinction of nation-state borders. Thus, the seminar seeks to open up an intellectual space to think about migration beyond the established parameters of policy and media discourses which frame migration either as a security issue, an economic asset or a humanitarian concern.

Course description:

The course reviews major issues concerning new global social movements and their core characteristics. At the center of the course are the movements that emerged with the crisis since 2008 (the "Arab Spring," Greece, 15-M/Spain, Gezi/Turkey, Occupy...). The course will discuss different approaches in social movement theory. It will also analyze movements that can be considered precursors regarding content and practices of the new global social movements (e.g. the "anti-representational" movements in Latin America since the mid-1990s and the alter-globalization movement). The course will discuss shared characteristics and differences among the new global movements and compared to earlier social movements. These changes will be contextualized in an analysis of changing political and cultural circumstances (crisis of representation, globalization, global governance...) and of new practices (non-representational democracy, direct action, self-management...) and perspectives of social movements.

Course description:

The literature on creative industries have hugely increased in the last decades, focusing on their relevance for artists and "creative workers" as well as for cities and countries. While creative industries national features prevail in the analyses, this course will examine their global dimensions. Departing from a discussion on global markets, their organizational and institutional contexts, we will then analyze the globalization of the creative industries and the establishment of transnational networks of individuals and firms in this sector. Aspects of (a) the production process, involving the organization of firms and labor conditions, (b) the distribution networks, also with respect to value creation, and (c) consumer behavior, including the formation of transnational network of fans and tourism, will be part of our discussions. Case studies on different branches – music, literature, cinema, arts – will be debated and taken as inspiration for students' essays. Theoretically, this course brings together insights of economic sociology, sociology of the arts as well as global and transnational sociology.
